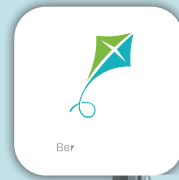

- **Mobile App:** You can use the Chard Snyder mobile app to pay for eligible expenses.
- **Online:** You can use the Chard Snyder website to pay for eligible expenses.
